

! Please note! Students who are nationals of a country outside the European Union and who need to renew their residence permit (https://dofi.ibz.be/fr/themes/third-country-nationals/etudes) with the Belgian Immigration Office must be registered for a minimum of 54 ECTS.

This balance may be lower because the student is in their final academic year, or because, through no fault of their own, they are unable to accumulate a higher number of credits.
